Special Individual Recognition Awards:

Brendan McCarthy Memorial Award – Intended to recognize a CREBA member whose charitable and philanthropic work best personifies the selfless qualities identified with the life and career of Brendan McCarthy.

Joseph Stettinius Jr. Leadership Award – This award recognizes industry leadership and management and will be given to an individual active today in a high-level leadership position at any firm related to commercial real estate (This could include leaders at a brokerage house an architectural firm, construction firm, financier, owner, etc.) It will recognize a leader who is kind, compassionate, visionary and smart. A TRUE LEADER who puts the good of all his or her colleagues first and is a confidant and great friend to the business community – all the things that Joe tried to accomplish in his leadership roles.

James L. Eichberg Broker of the Year – This award recognizes sustained excellence in brokerage. Recipients of the Broker of the Year will be selected based on their overall production during the current year and prior years, along with their display of leadership qualities within their respective firms, and overall participation in the commercial real estate industry.

NEW AWARD FOR 2025 – Agent of Change Award - This award honors an individual at any level within an organization who consistently advocates for and supports professionals from under-represented groups.
